From the corporate boardroom to political office, Indigenous women have been reclaiming their roles as leaders, healers, builders and advisors in Indigenous and non-Indigenous contexts alike. But we've only begun to walk the road to representation of Indigenous women in leadership. Currently, only 2.4 per cent of organizations in Canada have a woman who identifies as Indigenous in an executive officer role. Less than one per cent of MPs are Indigenous women.

On April 5, 2022, a power panel of Indigenous women leaders will join their friend and BLG partner [Cherie Brant](#) for a lively and honest conversation about the road to representation. All five women are citizens of different Nations and have filled different leadership roles in their communities and across Canada. Together, they'll explore their roots, where they are today and what they envision for the future. What's working? What's broken? What's got them excited? And what do they recommend to support the next generation of Indigenous women leaders? Join us to find out.
