John-Paul has extensive knowledge of school board operations and often appears at school board trustee meetings to provide clear explanations of complex matters, including governance, student and executive compensation matters.

John-Paul teaches education law to upper-year law students at the Queen's University Faculty of Law. In the past, he has taught industrial relations and labour law at George Brown College and Osgoode Hall Law School, where he was the program director for the Master of Laws in Labour and Employment Law. John-Paul is also on

the Board of Directors and one of the founders of the Canadian Network of Education Human Resource Professionals [CNEHRP](#) which held its inaugural conference in Vancouver in March 2025.
