Most recently, she held the position of Minister of Environment and Protected Areas and was also the Minister of Energy and Minister of Justice. Previously, she worked in the corporate sector as a senior executive for the Canadian Energy Pipeline Association and Enbridge. She earned a Master of Laws (LLM) in 2015 with a published thesis on the evolving role of the National Energy Board. She also worked in private practice as a litigator for 13 years.
