

# OpenText completes US\$1 billion senior secured notes offering as part of Micro Focus acquisition financing

On December 1, 2022, Open Text Corporation (Open Text or the Company) (NASDAQ: OTEX) (TSX: OTEX) announced the closing of its offering (the Notes Offering) of US\$1 billion principal amount of 6.90 per cent senior secured fixed rate notes due 2027 in connection with its proposed acquisition (the "Acquisition") of Micro Focus International plc. The net proceeds from the Notes Offering, borrowings under the term loan facility due 2029 and the Company's existing revolving credit facility, and cash on hand will be used to fund the Acquisition.
