Among other things, the transaction included the assignment of existing loans and the appointment of a new administrative agent, followed by an amendment and restatement of the existing credit facility, and post-closing syndication to multiple private lenders.
- Represented Telesat, one of the world's largest satellite operators, in its \$2.54B funding agreements (for its subsidiary, Telesat LEO Inc.) with the Government of Canada and the Government of Québec for its broadband satellite constellation, Telesat Lightspeed network.
