Canadian Pacific Railway Company*, [2025 QCCA 230](#)): Antoine is part of the team representing the company's interests in all legal proceedings in Québec concerning the derailment that occurred in Lac-Mégantic in July 2013, a major case that raises complex civil liability issues.

- **Representation of Google LLC** (*Option Consumers v. Google*, [2022 QCCS 2308](#)): Antoine acts on behalf of the company in a class action regarding its compliance with the legislative and regulatory framework on privacy and personal data protection.
- **Defense of Peoples Trust Company**: He represents the financial institution in a class action concerning the activation fees for prepaid credit cards.

Bourgeois*, [2023 QCCA 826](#)).
- **Defense of FCA Canada Inc.**: He represents the automobile manufacturer's interests in a class action concerning the use of key fobs regarding an issue related to product liability and compliance with the *Consumer Protection Act*.
- **Representation of McGill University**: Antoine defends McGill University in a class action regarding health insurance premiums for students, a case involving contractual rights and regulations applicable to group insurance.
- **Montreal Airport Authority** (*Pollués de Montréal-Trudeau (LPDMT) v. Aéroports de Montréal (ADM)*, [2021 QCCS 367](#), upheld by *Pollués de Montréal-Trudeau v.
