officials on pipelines, oil and gas markets, foreign investment, securities regulation, labour markets, climate change, carbon pricing and other energy and financial policy issues.

From 1997 to 2002, Alan worked in the corporate/commercial department of an international law firm based in London, England and an investment bank in New York.

Alan is a member of Young Presidents' Organization, the Canadian Rhodes Scholarship Selection Committee, and the Contemporary Calgary board of directors. He is a former board member of the Calgary International Film Festival, Canadian Energy Executive Association, the Canadian American Business Council and the Emerald Foundation.
