

Canada Housing Trust™ No. 1 completes C\$5.25B public offering

On June 20, 2017, Canada Housing Trust™ No. 1, a special purpose securitization trust, completed a debt financing consisting of the issuance of 1.750% Canada Mortgage Bonds™, Series 78 (Re-Opening), in an aggregate principal amount of \$5,250,000,000, which was provided with Canada's sovereign guarantee through Canada Mortgage and Housing Corporation (CMHC).
