Rambod was also the Canadian Competition Bureau's first Deputy Commissioner of the Competition Promotion Branch, where he was responsible for economic advocacy, international negotiations, strategic planning and communications. He is the author of a book on international trade law and numerous articles and presentations on international law and international economic regulation, and has taught international economic and trade law in various universities in Canada and Europe.
