We commend the BlackNorth Initiative (BNI) for initiating the Law Firm Pledge. The Canadian Association of Black Lawyers (CABL), played an important role in our collaborative discussions. We will continue to work with BNI, CABL and other stakeholders across the legal profession to break down barriers to the recruitment, retention, and advancement of Black people in our firms. Stronger together, we will drive progress and deliver lasting change.
