Experience

- **Protection of Confidential Information – Counsel’s Eyes Only Restrictions** — Litigation counsel to the plaintiff (application respondent) in successfully **resisting a broad “counsel’s eyes only” confidentiality regime** in a complex dispute involving alleged misuse of confidential information by former employees and a competing business. **The Court rejected the requested blanket restriction**, holding that the defendants had not established a real and substantial risk of harm to justify excluding the plaintiff from access to key evidence. ([2026 BCSC 862](#)).

- **Real estate dispute – Certificates of Pending Litigation.** Litigation counsel to the registered owner of lands in a petition to discharge a certificate of pending litigation. Despite the complexity of the underlying pleadings, which advanced contractual, misrepresentation, and unjust enrichment theories, the Court discharged the certificate of pending litigation because the plaintiff failed to plead a coherent nexus between the claims and the subject property ([2026 BCSC 529](#)).
- **Real estate dispute – Collapsed transactions.** Litigation counsel to the vendor in a collapsed transaction where the purchaser claimed specific performance, obtaining an order for further discovery because the witness was non-responsive and his conduct was antithetical to the purpose of discovery ([2025 BCSC 2179](#)).
- **Real estate dispute – Certificates of Pending Litigation.** Litigation counsel to a defendant in an action by a former business associate who sought and obtained certificates of pending litigation after alleging a conspiracy in respect of several real estate transactions. The certificates of pending litigation were discharged because they were creating hardship and inconvenience ([2025 BCSC 2095](#)).
- **Joint venture dispute.** Litigation counsel to a joint venture partner in a claim that involved alleged breach of fiduciary and contractual duties, obtaining an adjournment of the trial on the commencement date due to incomplete disclosure by the opposing parties ([2025 BCSC 2273](#)).
- **Construction dispute.** Appellate counsel to a contractor, successfully resisting leave to appeal from an arbitration award, clarifying the interplay between sections 58 and 59 of the Arbitration Act (British Columbia) and the Court of Appeal’s jurisdiction ([2025 BCCA 166](#)).
- **Construction dispute.** Arbitration counsel to a general contractor in a dispute relating to **non-payment**, successfully advancing a claim to obtain **compensation for services** rendered, and defending against claims for alleged **defects, and deficiencies** (2024).
- **Share purchase dispute.** Arbitration counsel to the purchaser of shares in a **post-closing adjustments** dispute, focussing on the application of generally accepted accounting principles (GAAP) (2024).
- **Real estate dispute - Commercial leasing.** Litigation counsel to landlord in a petition brought by a tenant for **relief from forfeiture** after the lease was terminated, successfully avoiding the reinstatement of the lease (2024 BCSC 2246).
- **Protection of Public Participation Act (PPPA) dispute.** Litigation counsel in defence of an application to dismiss counterclaims, successfully avoiding dismissal while confirming that **the PPPA did not protect against physical acts that lead to expression** ([2024 BCSC 570](#)).
- **Partnership dispute.** Litigation counsel to a limited partnership and its general partner in an application seeking and successfully obtaining a **stay of court proceedings** by a limited partner **in favour of arbitration** ([2024 BCSC 528](#)).
- **Defamation - Injunction.** Litigation counsel in defence of an application for a **broad sweeping gag order** relating to allegations of past and prospective instances of defamation, seeking and successfully obtaining a **dismissal of the application** and special costs ([2023 BCSC 2112](#)).
- **Protection of confidential information- Injunction.** Litigation counsel to the applicant seeking an injunction, successfully obtaining an interlocutory order preventing former employees and a former consultant from using **confidential and proprietary information**, including software code, in circumstances where there is a strong prima facie case of **breach of fiduciary duty** and **civil conspiracy** ([2023 BCSC 1187](#)).
- **Asset purchase dispute.** Arbitration counsel to a vendor of mining assets, responding to allegations of **breach of warranty** and allegations of **fraudulent misrepresentation** (2023).
- **Construction dispute.** Litigation counsel to a real estate developer seeking and successfully obtaining an order **dismissing Builders Lien Act claims** by relying on **accrued limitation defences** after the plaintiff was dissolved (2021).

- **Partnership dispute.** Litigation counsel to a limited liability partnership and its managing partner, defending against an attempt by an equity partner to **dissolve the partnership** (2020-2021).
- **Construction dispute.** Litigation counsel to a general contractor in a claim relating to the construction of public highways, **successfully avoiding summary judgment while clarifying the law** on what it means for an applicant to put its best foot forward ([2019 SKQB 254](#)).
- **Real estate dispute - Collapsed transactions.** Appellate counsel to a real estate developer who succeeded at trial by obtaining declarations contracts were valid and enforceable, successfully obtaining a **dismissal of the appeal** ([2018 BCCA 337](#)).
